RULES & REGULATIONS

The Mushroom Festival will take place Saturday and Sunday, September 9th and 10th, 2006 in downtown Kennett Square, PA. Festival hours are from 11 AM – 7 PM on Saturday and 10 AM – 5 PM on Sunday. This is an outdoor street festival and will be held rain or shine.

Fees: \$250 / 2 days

Space Size: 10' X 10'

- All craft vendors must actually be selling their product at the Festival. Vendors that are **promoting** their product only, must submit a Commercial Vendor Application. These vendors will be located in our Business Expo area.
- The Selection Committee will meet every two weeks to consider all applications received at that time. The Committee's decision is based on the needs of The Mushroom Festival and is final.
- Vendors will be notified of their acceptance status by mail. Space assignment and set-up information will be mailed in mid-August.
- The Selection Committee has the right to accept buy/sell vendors on a limited basis when their product compliments the overall theme of the event.
- **Preference will be given to vendors featuring mushroom items.**
- No T-Shirts with a mushroom design or any merchandise displaying The Mushroom Festival logo is allowed.
- All vendors must supply their own 10' X 10' canopy or rent one of ours.
- All display and merchandise must be placed within your 10' X 10' space. Items may not extend into the street more than 10 feet from the curb or extend behind your booth space.
- No booth sharing is allowed.
- Volunteer Block Captains will be available to answer questions and assist vendors as needed throughout the day.
- The Mushroom Festival is held rain or shine
- Overnight security will be provided. Each vendor is responsible for securing their booth. The Festival is not responsible for any loss or theft incurred by any vendor.
- Vendors are responsible for removing all trash from their area each evening and may not use Festival trash receptacles for its disposal.
- Vendor must notify the Mushroom Festival immediately of cancellation. No refunds will be granted within 30 days of the show.
